



ENACTED FURTHER, that the Disaster Report dated December 6, 2024, of the Social Services Department (SSD) shall be charge to the Quick Response Fund (QRF) from the Department of Disaster Resilience and Management (DDRM) with AIP Reference 1000-001-2-921-150-005-001 and Account Code of Other MOOE: 5-02-99-990, with CN: 2024-041 shall form part of this ordinance.
