WHEREAS, the Pag-Asa Sa Paglaya Multi-Purpose Cooperative (PSP), has requested the City Government of Muntinlupa for a loan assistance in the amount of One Million Pesos (Php1,000,000.00) to be taken from the 2024 Executive Budget under the City Cooperative Fund;

WHEREAS, the Pag-Asa Sa Paglaya Multi-Purpose Cooperative (PSP), has submitted to the City Cooperative Office all the requirements in applying for loan assistance;

WHEREAS, there is and available Budget from the 2024 Executive Budget of the City under the Cooperative Office;

NOW THEREFORE, ORDAIN, AS IT IS HEREBY ORDAINED, by the 9th Sangguniang Panlungsod of Muntinlupa to grant the loan assistance to Pag-Asa Sa Paglaya Multi-Purpose Cooperative (PSP), in the amount of One Million Pesos (Php1,000,000.00) to be taken from 2024 Executive Budget under Cooperative Fund of the City and authorizing the City Mayor, Hon. Rozzano Rufino B. Biazon to sign the Loan Agreement.

RESOLVED FURTHER, that a Certificate of Availability of Fund and Certificate of Fund Allotment shall be issued by the Office of the City Treasurer and City Budget, respectively.
