AN ORDINANCE APPROVING THE ANNUAL BUDGET FOR FY 2025 OF BARANGAY CUPANG, AMOUNTING TO ONE HUNDRED SEVEN MILLION NINE HUNDRED NINETY-SEVEN THOUSAND **HUNDRED FIFTY-SEVEN PESOS AND 50/100 (PHP107,997,857.50)**

WHEREAS, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "The Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code. xxx, as one of the corporate powers of the city xxx, shall: (i)"Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay.";

WHEREAS, the City Budget Office after evaluation of Barangay Cupang's submitted budget found the same to have complied with rules, regulations, and appropriate memoranda on budget preparation, recommended its adoption;

WHEREAS, the proposed expenditure program follows the development directions of the Barangay Development Plan as approved by the Barangay Assembly and is fully consistent with the approved barangay Annual Investment Program (AIP) for the Fiscal Year 2025;

WHEREAS, the sources of fund of Barangay Cupang as certified by the City Treasurer are as follows:



WHEREAS, the amount budget is allocated, as follows:

Personal Services - 47,698,793.20
Capital Outlay - 2,601,065.62
Maintenance and Other Operating Expenses (MOOE)
Statutory and Mandatory Expenses - 38,287,998.68

WHEREAS, in compliance with the mandatory requirements of the law, the following have been provided:

WHEREAS, the Barangay Appropriation Ordinance No. 24-007 Series of 2024, dated November 04, 2024 is recommended to be declared operative in its entirety effective January 01, 2025, posting requirements under Section 59 of RA 7160.;

WHEREAS, the City Budget Office recommended that the FY 2025 Annual Budget of Barangay Cupang be declared operative in the entirety effective January 1, 2024 subject to compliance with the:

a. Procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provisions of Republic Act 9184 (Government Procurement Reform Act) and prior clearances from pertinent agencies as maybe needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan:

WHEREAS, the Barangay Cupang FY 2025 Annual Budget was found to have substantially complied with the laws and the same was executed pursuant to the prescribed power of the barangay;

NOW THEREFORE, BE IT ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa, to approve the Barangay Budget for FY 2025 of Barangay Cupang, amounting to One Hundred Seven Million Nine Hundred Ninety-Seven Thousand Eight Hundred Fifty-Seven Pesos and 50/100 (Php107,997,857.50).

ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 13th day of January 2025, on its 129th Regular Session.
