WHEREAS, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "The Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx, as one of the corporate powers of the city as provided in Rule IX of these rules, and shall:

(i) "Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay.";

WHEREAS, the Budget and Management Department thru its Head, Mr. Necito M. Guico endorsed and recommended the approval of the **SK Barangay Ayala-Alabang 2024 Supplemental Budget** as it has complied with the rules, and regulations, and pertinent laws on budget;

WHEREAS, the Source of Fund for the SK of Barangay Ayala-Alabang came from the unremitted amount of the 10% share from Barangay Ayala-Alabang actual income for the year **2023** in the amount of **Seven Million One Hundred Ninety-One Thousand Pesos (Php57,191,000.00)** as certified by Acting City Accountant;

WHEREAS, the Supplemental for the SK of Barangay Ayala-Alabang is **Seven Million One Hundred Ninety-One Thousand Pesos (Php57,191,000.00)** and is consistent in the guidelines set in DBM-DILG-NYC No. 1, series of 2019 dated January 23, 2019.

WHEREAS, the Supplemental Budget amounting to **F Seven Million One Hundred Ninety-One Thousand Pesos (Php7,191,000.00)** shall be allocated to the PPAs:

WHEREAS, Pursuant to DBM-DILG-NYC No. 1, series of 2019 dated January 23, 2019, item 3.3.3.4, states that, "The SK Secretary shall submit the SK annual/supplemental budget to the Sangguniang Panlungsod, xxx, through the city/municipal budget officer, within ten (10) days upon approval thereof";

WHEREAS, in view of the foregoing the Budget Officer recommended that the Sangguniang Kabataan of Barangay Ayala-Alabang 2024 Supplemental Budget be declared Operative in its entirety effective October 28, 2024, subject to posting requirements under DBM-DILG-NYC No. 1, series of 2019 dated January 23, 2019;

NOW THEREFORE, BE IT ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa, to approve the **Supplemental Budget** for FY 2024 of Sangguniang Panlungsod of the **Barangay Ayala-Alabang**, amounting to **Seven Million One Hundred Ninety-One Thousand Pesos (Php7,191,000.00)** to be taken from the unremitted amount of the 10% share from the 2023 Barangay Ayala-Alabang Budget.

ENACTED, by the 10th Sangguniang Panlungsod of **Muntinlupa** this 13th day of **December, 2025**, on its 129th Regular Session.
