**WHEREAS**, Article 99, 2(i) of the implementing Rules and Regulations of the LGC, states that the Sanggunian Panlungsod, "Shall approve the annual and supplemental budgets of the City government and appropriate funds for specific programs, projects, services, and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants";

WHEREAS, Sections 312 and 319 of the LGC and Article 417 of its implementing Rules and Regulations (LGC-IRR), as amended by Administrative Officer (A.O.) No. 17 series of 1993, "Allow changes in the Annual Budget of the LGU through a supplement in the Annual Budget under specified circumstances and pursuant to the requirements of the LGC and other applicable laws, rules, and regulations";

WHEREAS, the *Consolidated Supplemental Annual Investment Program No. 1, FY 2025* duly approved by the Sanggunian Panlungsod through Resolution No. 2025-657, indicated that the Supplemental Budget No. 1 amounting to *Twenty-Three Million Seventy-Nine Thousand Pesos (Php23,079,000.00)* will be utilized for the *grant of SRI qualified Regular and Casual Employee and Gratuity Incentive for HO, BHW, Kabalikat and COS.*

NOW THEREFORE, BE IT ENACTED, by the 10<sup>th</sup> Sangguniang Panlungsod in a Session assembled that:

**SECTION 1. Short Title.** This Ordinance shall be known as approval of Supplemental Budget No. 1, (SUPBUD6) for FY 2025;

**SECTION 2. Source of Funds.** The source of funds for the SUPBUD No. 1 for FY 2025 in the total amount of *Twenty-Three Million Seventy-Nine Thousand Pesos (Php23,079,000.00)* shall be taken from the 2024 Executive Budget - Saving of the City.

**SECTION 3. Utilization of Appropriated Fund.** The funds herein approved shall be released and utilized strictly in accordance with applicable budgeting, accounting, and auditing laws, rules, and regulations.

**SECTION 4. Separability Clause** - If for any reason, part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full force and effect.

**SECTION 5. Repealing Clause** - all other existing ordinances, executive orders and administrative regulations or part of parts thereof which are inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

**SECTION 6. Effectivity** – The ordinance shall take effect upon approval.

ENACTED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 13<sup>th</sup> day of January 2025, on its 129<sup>th</sup> Regular Session.
