AN ORDINANCE EXTENDING THE DEADLINE FOR THE RENEWAL OF BUSINESS PERMITS AND LICENSES PAYMENT OF FEES OR CHARGES WITHOUT SURCHARGES OR PENALTIES UNTIL 31 JANUARY 2025

WHEREAS, Section 16 (General Welfare Clause) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991 (LGC)," states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"

WHEREAS, Section 167, Chapter III, supra, on the Time of Payment in the Collection of Taxes, provides that "Xxx, all local taxes, fees, and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case may be. The Sanggunian concerned may, for a justifiable reason or cause, extend the time for payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months;"

WHEREAS, the Business Permits and Licensing Office (BPLO) of the City Government of Muntinlupa, in a letter addressed to the City Mayor dated January 8, 2025 requested the extension of the deadline of the 2024 Business Permit Renewal from 20 January 2025 to 31 January 2025, citing that based on last year's data, 42.72% only of applicants were processed within the first 20 calendar days compared to the total number of registered businesses from the previous year".


NOW THEREFORE, BE IT ENACTED, by the 10th Sangguniang Panlungsod in Session assembled that:

SECTION 1. Title. This Ordinance shall be known as the “Ordinance Extending the Deadline for the 2024 Business Permit Renewal from 23 January 2025 to 31 January 2025.”



SECTION 2. Extension. The deadline for the renewal of Business Permits payment of Fees, and Licenses in the City Government of Muntinlupa for the Calendar Year (CY) 2024 shall be extended from 20 January 2025 to 31 January 2025

SECTION 3. Publication and Dissemination. This Ordinance shall be published pursuant to the requirements of the Local Government Code and shall be posted on the Official Website of the City Government of Muntinlupa.

SECTION 4. Separability Clause. If any portion of this Ordinance is declared invalid, the remainder of this Ordinance shall not be affected and shall remain valid and enforceable.

SECTION 6. Effectivity. This Ordinance shall take effect immediately upon its approval.


