



WHEREAS an internship program is meant to provide medical practitioners the opportunity to complement their formal learning with practical knowledge, skills and desirable attitudes needed in their field of practice;



NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the *Hon. City Mayor Rozzano Rufino B. Biazon*, to enter into and sign the **Memorandum of Agreement (MOA)** with Asian Hospital, Inc., represented by its President and Chief Executive Officer, Dr. Beaver R. Tamesis, Chief Medical Officer, Dr. Jose M. Acuin, M.D., and Associate Doctor for Medical Affairs, Dr. Carlos Vicente G. Gabriel, M.D., on the conduct of practical training for AHI's postgraduate interns in community medicine and public health at the Muntinlupa City Health Office

**RESOLVED FURTHER** that the Internship Agreement shall comply with the requirements setforth by prevailing guidelines and rules by the Commission on Higher Education or any government instrumentalities which have jurisdiction therein;

**RESOLVED FINALLY**, that should there be fee/s or charges imposable under the terms of the Internship Agreement, the same shall benefit the coffers of the City Government of Muntinlupa.
