

WHEREAS, Section 455 (a) (vi) of Republic Act 7160, otherwise known as the Local Government Code, provides that, ***"the city mayor, as chief executive of the city government, shall exercise such powers and perform such duties and functions as provided by the Code and other laws and shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance"***;

WHEREAS an internship program is meant to provide medical practitioners the opportunity to complement their formal learning with practical knowledge, skills and desirable attitudes needed in their field of practice;

WHEREAS, Asian Hospital Inc., is the owner of Asian Hospital and Medical Center which is a participant in the National Internship Program for the medical graduates under the Association of Philippine Medical Colleges Inc.,;

ADOPTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 18th day of **October, 2024**, on its 122nd Regular Session.


