WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **"Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;**

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-IRR), provides that, **"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";**

WHEREAS, Makati Medical Center (MMC) is one of the private hospital located in the City of Makati duly authorized by competent authority to conduct research, education and training, to produce specialist in all fields of medicine, surgery, obstetrics and gynecology, pediatrics and anesthesiology among others;

WHEREAS, MMC a private hospital having been accredited to implement residency training Program wishes to enhance its existing program, more particularly in the field of Anesthesiology, by allowing its residents to can gain more experience while providing additional manpower to Ospital ng Muntinlupa;

WHEREAS, Ospital ng Muntinlupa is a government hospital which provides training to residents from various hospitals;

WHEREAS, the Affiliation Contracts between the Ospital ng Muntinlupa and various educational institutions for affiliation/training and residence of the latters students/residents.

WHEREAS, the Ospital ng Muntinlupa will allow the affiliation and training of the institutions' students/residents for a **fee of Two Thousand Three Hundred Pesos (Php2,300.00)** per students per month;

WHEREAS, the City Legal Office has no objection to the Affiliation Contract, subject to compliance with the pertinent guidelines on the Commission on Higher Education and the Department of Health (CHED);

WHEREAS, this CoAf shall take effect for a period of one (1) year from September 15, 2024 to September 14, 2025;

NOW THEREFORE, BE IT RESOLVED, AS IT HEREBY RESOLVED, by the **10th Sangguniang Panlungsod**, to authorize the **City Mayor Hon. Mayor Rozzano Rufino B. Biazon**, to enter into and sign thru the **Ospital ng Muntinlupa (OsMun) the Contract of Affiliation (COAf) with Makati Medical Center (Medical Doctors, Inc.,)** represented by **Dr. Saturnino P. Javier, MD, Director**, on the implementation of a training program in **Anesthesiology** for the benefit of medical practitioners in Ospital ng Muntinlupa..
