



**WHEREAS**, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”;**

**WHEREAS**, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **“Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”;**

**WHEREAS**, Republic Act No. 9003, otherwise known as the “Ecological Solid Waste Management Act of 2000, was approved on January 16, 2001, anchored on the State Declaration of Policies to provide a systematic, comprehensive, and ecological solid waste management to, among others, utilize environmentally-sound methods that maximize the use of valuable resources and encourage resource conservation and recovery;





**WHEREAS**, Republic Act 7924 mandates the **Metro Manila Development Authority (MMDA)** to formulate and implement policies, standards and projects for integrated flood control, drainage and sewerage systems in Metro Manila including the installation of trash traps in selected waterwaste of the Metro-Manila;

**WHEREAS**, the local government units, by virtue of Republic Act No. 7160 is mandated to provide services and facilities related to general hygiene and sanitation, beautification, and solid waste collection align with the support and monitoring of the Local Government of Muntinlupa and other national government agencies;

**WHEREAS**, the **Metro Manila Development Authority (MMDA)** will purchase, deliver and install manual garbage traps, collection tools such as but not limited to floating pontoon, fabricated scooper, etc., to be provided in selected waterways as identified by the Local Government of Muntinlupa;

**WHEREAS**, the **Barangay** shall operate and maintain the installed trash traps and allocate funds therefor, enact appropriate barangay ordinances relative thereto and provide monthly reports on the volume of trash collected;

**WHEREAS**, the City and Barangay Officials, and upon compliance to the technical requirements of the project, the MMDA have installed trash traps along waterways under the geographical jurisdiction of the City of Muntinlupa, which are now operational. The following Barangays are:

- i. **Sucat**
- ii. **Cupang**
- iii. **Buli**
- iv. **Alabang**
- v. **Tunasan**
- vi. **Poblacion**
- vii. **Putatan**
- viii. **Bayanan**

**WHEREAS**, the installation of the subject trash traps will block garbage and when regularly collected, hauled and disposed of will minimize, if not, prevent flooding;


