 WHEREAS, Section 7, of 1987 Philippine Constitution, states that, "xxx. The State shall protect of subsistence fishermen, especially of local communities, to the preferential use of the communal marine and fishing resources, both inland and offshore. Xxx. The state shall also protect, develop and conserve such resources."

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, "Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.";





WHEREAS, the renewal of the Memorandum of Agreement (MOA) is between the City Government of Muntinlupa through DA-ESO with the Bellevue Hotels and Resorts (The Bellevue Manila) represented by its Managing Director, Mr. Patrick Chan on the implementation and operations of the Bellevue Manila Roof Deck Garden Sustainability Project;

WHEREAS, under the MOA the DA-ESO will provide technical assistance to Bellevue Hotels in the maintenance and planting system improvement of the roof deck garden. Expenses for the maintenance of the garden, materials and wages of the gardener will for the account of Bellevue Hotels;

WHEREAS, the Office of the City Attorney has no objection to the MOA as the provision of technical assistance is consistent with the mandate of the DA-ESO and the City's 7K Agenda;


WHEREAS, the City Government of Muntinlupa and the DA-ESO will regularly inspect the garden to ensure that proper procedures are being followed and to monitor effective garden maintenance.

WHEREAS, the responsibilities of Bellevue Manila and the City Government of Muntinlupa is the same under the Terms and Conditions of the MOA;

NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon** to enter and sign through the Department of Agriculture, Extension Services Office the **Memorandum of Agreement (MOA)** with **Bellevue Hotels and Resorts (The Bellevue Manila)** represented by its **Managing Director, Mr. Patrick Chan** on the implementation and operations of the Bellevue Manila Roof Deck Garden Sustainability Project.






