





WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **“Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”;**

WHEREAS, pursuant to Article 99, 2(i) of the LGC Implementing Rules and Regulations, the Sangguniang Panlungsod, **“Shall approve the annual and supplemental budgets of the City government and appropriated funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law in order to promote the general welfare of the City and its inhabitants”;**

WHEREAS, on November 22, 2024, the City Development Council (CDC) pursuant to its mandate to appraise and prioritize socioeconomic development programs and projects of the local government unit, adopted its **“Resolution No. 09, Series of 2024 also known as, A Resolution adopting the consolidated Supplemental Annual Investment Program (AIP) No. 8 for FY 2024 and its Supplemental Budget FY. 2024, and favorably endorsing to the Sangguniang Panlungsod”;**

WHEREAS, the Supplemental AIP No. 8 setforth the various Programs, Projects And Activities (PPA) to be implemented by which will be funded from the **2023 Unexpended Appropriation** under the **General Fund** estimated to be worth **Sixty-Three Million Four Hundred Thirty Thousand Nine Hundred Thirty Pesos and 27/100 (Php63,443,930.27);**
