WHEREAS, Section 455 (b)(1)g(vi) of the Local Government Code provides that, the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants Pursuant to Sec 76 of RA7160, the city mayor shall represent the city in all business obligations, transactions and sign in its behalf all bonds, contracts and such other documents upon authority of the Sangguniang Panlungsod;

WHEREAS, Article B6(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs' projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, SECTION 33 of the LCG provides, "Local government units may, through appropriate ordinances, group themselves, consolidate, or coordinate their efforts, services, and resources for purposes commonly beneficial to them. In support of such undertakings, the local government units involved may, upon approval by the Sanggunian concerned after a public hearing conducted for the purpose, contribute funds, real estate, equipment, and other kinds of property and appoint or assign personnel under such terms and conditions as may be agreed upon by the participating local units through Memoranda of Agreement.";

WHEREAS, on October 1, 2024 the Office of the Sangguniang Panlungsod of the City of San Pedro Laguna adopted Resolution No. 2024-197 granting authority to the Hon. Art Joseph Francis Mercado to enter into an Affiliation Agreement with the City of Muntinlupa for the assignment and rotation of resident trainees from its City Health Office to the Ospital ng Muntinlupa;


WHEREAS, the Affiliation Agreement shall be for the minimum period of four (4) years where Family and Community-Based Doctors of Medicine of San Pedro Laguna will be resident-trainees in the Ospital ng Muntinlupa where they will gain knowledge and skills and opportunity to become Family Medicine Specialist;

WHEREAS, the terms, conditions, rights and obligations of the parties in the Affiliation Agreement were reviewed the City Legal Office of Muntinlupa City with the opinion that " it is subject to compliance with pertinent guidelines and issuances of the Department of Health Department Order No. 2013-0171" and the Data Privacy Law;

NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa to authorize the Hon. City Mayor Rozzano Rufino B. Biazon to represent the City Government of Muntinlupa in an **Affiliation Agreement** with the City Of **San Pedro, Laguna** represented by **Hon. Mayor Art Joseph Francis Mercado** the Assignment and Rotation Of Family And Community-Based Doctors Of Medicine Of The **City Health Office, San Pedro Laguna** to the **Ospital Ng Muntinlupa**.

ADOPTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 16th day of December, 2024, on its 126th Regular Session.
