**WHEREAS**, Section 455 (b)(1)g(vi) of the Local Government Code provides that, the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants Pursuant to Sec 76 of RA7160, the city mayor shall represent the city in all business obligations, transactions and sign in its behalf all bonds, contracts and such other documents upon authority of the Sangguniang Panlungsod;

**WHEREAS**, Article B6(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs' projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

**WHEREAS**, an academic affiliation is being proposed by the two departments under the Executive office of the City Government of Muntinlupa, under which the level 3 Ospital ng Muntinlupa and the TESDA-recognized Muntinlupa City Technical institute (MCTI) will be parties to a written agreement for the former to accept and train the caregiving students of the latter;


**WHEREAS**, the Contract of Affiliation (CoAf) complements the 7K Agenda of the present administration under Karunungan and Kabuhayan;




