**WHEREAS**, Section 455 (b)(1)g(vi) of the Local Government Code provides that, the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants Pursuant to Sec 76 of RA7160, the city mayor shall represent the city in all business obligations, transactions and sign in its behalf all bonds, contracts and such other documents upon authority of the Sangguniang Panlungsod;

**WHEREAS**, Article B6(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs' projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";


**WHEREAS**, Technical Education and Skills Development Authority (TESDA) Memorandum Circular No. 107 Series of 2021, also known as the Omnibus Guidelines on Technical Vocational Education and Training (TVET) Program Registration, empowers TESDA to establish and maintain a system of accrediting, coordinating, integrating, monitoring and evaluating formal and non-formal NET programs provides for the **Supervised Industry Learning (SIL)** designed to complement the training gained in the institution with the intention of enhancing the knowledge and skills of a Learner through actual application of the core competencies in the workplace, as identified in the training regulations;

**WHEREAS**, the City Government of Muntinlupa (CGM), through its Muntinlupa City Technical Institute (MCTI), supports the implementation of Republic Act No 7796 or the TESDA Act of 1994, where local government units shall assume the responsibility for effectively providing community-based technical education and skills development opportunities;

**WHEREAS**, pursuant thereto and in consonance with the 7K Agenda, the CGM enters into a Memorandum of Agreement for SIL with **Department of Social Welfare and Development –National Capital Region (DSWD-NCR)**, a local enterprise where learners for course/s Skill Training of the MCTI Students to the residents and staff members of the Elsoe Gaches Village shall be immersed to experience practical training;

**WHEREAS**, the MOA was submitted for review and the City Legal Office interposed no objection as long as the relevant laws guidelines and circulars on the matter are complied with.
