WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, Section 25 of the LGC authorizes, "National agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects;"

WHEREAS, pursuant to the 7K Agenda of the City Government, to become productive members of the City entails the creation of an opportunity to be gainfully employed which is achievable through education and skills training;

WHEREAS, the creation of a Job Placement Office (JPO) envisioned in a tripartite collaboration between the City Government of Muntinlupa's Public Employment Office (PESO), Colegio de Muntinlupa (CDM) and the Department of Labor and Employment (DOLE), entails free employment facilitation, human resources services development, labor market information, and other key employment generators that will assist in exploring better career options;

WHEREAS, under the MOU, the Colegio de Muntinlupa (CDM) shall be constituted by the DOLE as an accredited JPO until mutually terminated;

WHEREAS, the City Legal Office has no objection on the provision of the **Memorandum of Understanding (MOU)**, as the same is consistent with the mandate of PESO as mandated in R.A. 10691 and its IRR as accredited JPO;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize The City Mayor Hon. Rozzano Rufino B. Biazon to enter into a *Memorandum Of Understanding (MOU)* with the *Department of* Labor and **Employment (DOLE)** represented by *Atty. Sarah Burna S. Marisol* Regional Director on the creation of a *Job Placement Office (JPO)* in coordination with the Public Employment Service Office (PESO) for graduate students of Colegio de Muntinlupa (CDM)

ADOPTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 16th day of December, 2024, on its 126th Regular Session.
