**WHEREAS**, Republic Act 7160 provides that basic services and facilities of the local government units include facilities and other tourist attractions, including the acquisition of equipment, regulation and supervision of business concessions, and security services for such facilities;

**WHEREAS**, Section 37 of the Tourism Act of 2009 , provides that, "Local Government Units, in consultation with stakeholders, are encouraged to utilize their powers under Republic Act No. 7160, otherwise known as the Local Government Code of 1991, to ensure the preparation and implementation of a tourism development plan, the enforcement of standards and the collection of statistical data for tourism purposes. They shall, insofar as practicable, prepare local tourism development plans that integrate zoning, land use, infrastructure development, the national system of standards for tourism enterprises, heritage and environmental protection imperatives in a manner that encourages sustainable tourism development.";

**WHEREAS**, the Tourism, Culture and the Arts Department (TCAD) of Muntinlupa City submitted a Tourism Circuit and Cultural Development Plan ( TCCDP) 2025-2031;

**WHEREAS**, the TCCDP has the following integrated programs:

1. Discover Muntinlupa Program
2. Preserving Muntinlupa's History, Heritage and Culture Program
3. Empowering Business and Employment Program
