





WHEREAS, on March 5, 1990 the then Sangguniang Bayan authorized the then Municipal Mayor Atty. Ignacio R. Bunye to purchase government securities such as treasury bills with the objective that any yield from the placements will inure to the benefit of the municipal government;

WHEREAS, the interest of the fund placements were used to construct government facilities including the Peoples' Center Building which unofficially houses the members of the Sangguniang Panlungsod, Vice Mayor's Office and some Executive Office;

WHEREAS, for more or less thirty five (35) years, the City Councilors, the Secretariat and the Vice Mayor's Office conducts its business, meetings, committee and public hearings, and other official functions in the Peoples' Center building;

WHEREAS, while there are efforts to repair and introduce some minor renovations to the building, the same would prove to be counterproductive as the same structure may come into the purview of condemnable one not merely because of its structural integrity but other risk factors;

WHEREAS, the need to construct a distinct and separate building for the Sanggunian Panlungsod and its Secretariat is long due;
