



**WHEREAS**, the Philippine Bar Examination is the professional licensure examination for lawyers in the country exclusively administered by the Supreme Court of the Philippines through the Supreme Court Bar Examination Committee;

**WHEREAS**, the 2024 Philippine Bar Examination, chaired by Supreme Court Justice Mario Lopez, was held on September 08, 11, and 15, 2024 in various regional testing venues nationwide;

**WHEREAS**, the Bar Exams cover the usual subjects including Political and International Law, Criminal Law, Labor Law and Social Legislation, Civil Law, Mercantile Law, Remedial Law, and Legal Ethics;

**WHEREAS**, on 13 December 2024, the Supreme Court En Banc released the official results of the 2024 Bar Examinations with 37.84% passing rate or 3,962 out of more than 10,000 examinees;

**WHEREAS**, Councilor Alexson Valeda Diaz is an incumbent Member of the 10<sup>th</sup> Sangguniang Panlungsod representing District 1 of the City of Muntinlupa and presently holding the chairmanship of the Committee on Public Order, Security, and Safety, Committee on Ways and Means, and Committee on Justice and Human Rights;


