AN ORDINANCE GRANTING THE TOTAL AMOUNT OF FIVE THOUSAND PESOS (PHP5,000.00) OF FINANCIAL ASSISTANCE TO ONE (1) FAMILY AFFECTED BY FIRE ON JANUARY 16, 2025, LOCATED AT BLOCK 5, LOT 8, DONAK ST. VICTORIA HOMES, BARANGAY TUNASAN, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare":

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, "The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx";

WHEREAS, on January 16, 2025, one (1) structure housing one (1) family, were gutted by fire at Block 5, Lot 8, Donak St. Victoria Homes, Barangay Tunasan, Muntinlupa City;

WHEREAS, in a report rendered by the Social Services Department on January 17, 2025 and received by the SP Secretariat Office on January 21, 2025 the following were noted as casualties of the said fire:

- 1. One (1) structure;
- 2. One (1) family;
- 3. Two (2) individuals with the following details:
 - a. One (1) Senior Citizen

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 10th Sangguniang Panlungsod, to grant the total amount of Five Thousand Pesos (Php5,000.00) of Financial Assistance to the one (1) family affected by fire on January 16, 2025, located at Block 5, Lot 8, Donak St. Victoria Homes, Barangay Tunasan, Muntinlupa City.

ENACTED FURTHER, that the Disaster Report dated January 17, 2025 of the Social Services Department (SSD), and shall be charge to the 70% Department of Disaster Resilience and Management (DDRM) Fund with AIP Reference 1000-001-2-921-150-005-001 and Account Code of Other MOOE: 5-02-99-990, with CN: 2025-01 shall form part of this ordinance.
