AN ORDINANCE GRANTING THE TOTAL AMOUNT OF FIVE THOUSAND PESOS (PHP5,000.00) OF FINANCIAL ASSISTANCE TO ONE (1) FAMILY AFFECTED BY FIRE ON JANUARY 16, 2025, LOCATED AT BLOCK 5, LOT 8, DONAK ST. VICTORIA HOMES, BARANGAY TUNASAN, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *"Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare"*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *"The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx"*;

WHEREAS, on **January 16, 2025**, one (1) structure housing one (1) family, were gutted by fire at **Block 5, Lot 8, Donak St. Victoria Homes, Barangay Tunasan, Muntinlupa City**;

WHEREAS, in a report rendered by the **Social Services Department** on **January 17, 2025** and received by the **SP Secretariat Office** on **January 21, 2025** the following were noted as casualties of the said fire:

1. One (1) structure;
2. One (1) family;
3. Two (2) individuals with the following details:
 - a. One (1) Senior Citizen

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10th Sangguniang Panlungsod**, to grant the total amount of **Five Thousand Pesos (Php5,000.00)** of Financial Assistance to the **one (1)** family affected by fire on **January 16, 2025**, located at **Block 5, Lot 8, Donak St. Victoria Homes, Barangay Tunasan, Muntinlupa City**.

ENACTED FURTHER, that the **Disaster Report** dated **January 17, 2025** of the **Social Services Department (SSD)**, and shall be charge to the **70% Department of Disaster Resilience and Management (DDRM) Fund** with **AIP Reference 1000-001-2-921-150-005-001** and **Account Code of Other MOOE: 5-02-99-990**, with **CN: 2025-01** shall form part of this ordinance.

ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **27th day of January, 2025**, on its **131st Regular Session**.
