System (EPCS) in government transactions and bring about more efficient and effective payment and collection services for the transacting clients and government office;

WHEREAS, Commission on Audit (COA) Memorandum Circular No. 2021-014, provides "Guidelines on the use of Electronic Collection (e-Collection) and Electronic Payment (e-Payment) for Government Transactions";

WHEREAS, in compliance to the mandate of all existing laws and national directives, the City Government of Muntinlupa through the Business Permits and Licensing Office (BPLO) established Business E-Payment System (BeST) as an online platform to facilitate applications for new and renewal of business permits. BeST also allows electronic payments through various partner banks, e-wallets, and payment gateways and also provides an option of doo-to-door delivery service; and

WHEREAS, with the above premises, there is an urgent need to institutionalize the said system to support and enhance city services in pursuit of being a "smart city" and be compliant with the said laws and national directives.

**NOW THEREFORE**, be it ordained by the 10<sup>th</sup> City Council in session assembled, to enact:

**Section 1. Title**. This Ordinance shall be known as "An Ordinance Institutionalizing Business E-Payment System (BeST) for Effective Implementation of the "Zero-Contact Policy" in the Issuance of Business Licenses and Permits in Muntinlupa City.

**Section 2.** Findings Incorporated. The findings and laws above are hereby incorporated and made integral part of this ordinance.

Section 3. Declaration of Policy. The City recognizes the use of electronic transactions in the government as a means of the Business Permits and Licensing Office (BPLO) to adopt the automated payment of business fees and charges as an alternative means of taxpayers in securing business permits.

**Section 4. Establishment**. The Business Permits and Licensing Office (BPLO) shall adopt and establish Business E-Payment System (BeST) as an online platform of the City Government of Muntinlupa to facilitate application for, processing of, and issuance of business licenses and permits for business entities, including, but not limited to, those owned and operated by individuals, partnerships, cooperatives, associations or corporations in the City of Muntinlupa. The BeST will guarantee

the effective implementation of the "zero-contact policy", transparency and good governance that eliminates the possibility of graft and corruption.

Section 5. Implementation. The implementation of BeST shall provide electronic versions of licenses, clearances, permits, certifications or authorizations with the same level of authority and containing the electronic signature of the authorized officer/s and seal of the City, which may be printed by the businesses in the convenience of their offices. The BeST will guarantee the effective implementation of the "zero-contact policy", transparency, and good governance that eliminates the possibility of graft and corruption with lesser personnel the taxpayer deals with.

Section 6. BeST Features and Procedures. The implementation of BeST shall enable businesses to obtain electronic versions of licenses, clearances, permits, certifications, or authorizations and print them conveniently from their own offices. These documents will include the electronic signature of the authorized officer(s) and the City's seal, thereby bearing the same legal authority as the ones processed on-site.

The procedures are outlined as follows:

1. Account Registration. Quick registration process through implementing a simplified registration form with email login options and a one-click email verification;

2. Dashboard Viewing. BeST user dashboard offers a userfriendly access to new and renewal applications guided by a stepby-step procedure and requirements. Users may directly upload required documents then submit the application to be reviewed by an online examiner;

3. Payment Methods. Seamless and secured transactions are ensured with multiple affiliated banks and online payments available; and

4. Permit Generation. Upon payment confirmation, users are notified via email of the generated permit. Businesses may opt to download and print it at the convenience of their office or have it delivered door-to-door through a partner courier.

Section 7. Feedback Mechanism. The online platform shall be supplemented by a live chat support available during office hours and shall also serve as a channel for receiving feedback. This feedback mechanism ensures that user

experience and other suggestions are duly recorded for the purpose of process refinement and continuous improvement of the system.

Section 8. Separability Clause. If any portion of this Ordinance is declared invalid, the remainder of this Ordinance shall not be affected and shall remain in full force and effect.

Section 9. Repealing Clause. All ordinances, rules, and regulations, or part thereof, where provisions are in conflict or contrary to the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.

Section 10. Effectivity Clause. This Ordinance shall take effect immediately upon its approval.
