AN ORDINANCE GRANTING THE TOTAL AMOUNT OF FIVE HUNDRED FIVE THOUSAND PESOS (PHP505,000.00) OF FINANCIAL ASSISTANCE TO TWENTY-SEVEN (27) FAMILIES AFFECTED BY FIRE ON JANUARY 30, 2025, LOCATED AT MARQUEZ COMPOUND ITAAS, BARANGAY PUTATAN, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *"Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare"*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *"The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx"*;

WHEREAS, on January 30, 2025, thirteen (13) structures housing twenty-seven (27) families, were gutted by fire at Marquez Compound Itaas, Barangay Putatan, **Muntinlupa City**;

WHEREAS, in a report rendered by the Social Services Department on January 31, 2025 and received by the SP Secretariat Office on February 3, 2025 the following were noted as casualties of the said fire:

1. Thirteen (13) structures;
2. Twenty-Seven (27) families;
3. Eighty-Eight (88) individuals with the following details:
  - a. Ten (10) Senior Citizens
  - b. Seven (7) Children (0-5 years old)

c. One (1) Casualty

**WHEREAS**, the Social Service Department (SSD) of the City of Muntinlupa and the *Barangay Chairman of Putatan* conducted a survey on the victims of the fire to determine the casualties basing the category of victim in accordance with prevailing ordinance, a recommendation for financial assistance in the amount of **Five Hundred Five Thousand Pesos (Php505,000.00)**;

**NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED**, by the **10<sup>th</sup> Sangguniang Panlungsod**, to grant the total amount of **Five Hundred Five Thousand Pesos (Php505,000.00)** of **Financial Assistance** to the *twenty-seven (27)* families affected by fire on **January 30, 2025**, located at **Marquez Compound Itaas, Barangay Putatan, Muntinlupa City**.


