AN ORDINANCE APPROVING THE 2025 ANNUAL BUDGET OF SANGGUNIANG KABATAAN (SK) OF BARANGAY PUTATAN, AMOUNTING TO FIFTEEN MILLION FIVE HUNDRED FORTY-NINE THOUSANDTWO HUNDRED SIXTEEN PESOS AND 01/100 (PHP15,549,216.01)

WHEREAS, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "the Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx, as one of the corporate powers of the city as provided in Rule IX of these rules, and shall: (i) "Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sangguniang and of the Punongbarangay.";

WHEREAS, on February 13, 2025, after the evaluation made by the City Budget Office, the 2025 Annual Budget of Sangguniang Kabataan (SK) of Barangay Putatan amounting to Fifteen Million Five Hundred Forty-Nine Thousand Two Hundred Sixteen Pesos And 01/100 (Php15,549,216.01) was endorsed to the Sangguniang Panlungsod for review;

WHEREAS, the SK Budget of Barangay Putatan as certified by the Barangay Treasurer for fiscal year 2025 is computed as follows:

WHEREAS, the City Budget Office recommended that the FY 2025 Annual Budget of SK *Barangay Putatan* be **declared operative in its entirety effective January 01, 2025** subject to compliance with the following:

- Posting requirements under DBM-DILG-NYC JMC No. 1 Series of 2019;**
- Appropriations to be disbursed in accordance with Art 425 of the IRR, of Republic Act 7160 (Local Government Code); RA 10742 (Sanggunian Kabataan Reform Act of 2015) and its IRR; DBM-DILG JMC No. 1 s. 2019;**
- Compliance to the implementing guidelines and procedure pursuant to Section 4, of RA 11768 (amendments to RA 10742) and DBM Local Budget Circular No. 148 dated December 23, 2022;**
- Procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provisions of Republic Act 9184 (Government Procurement Reform Act) and prior clearances from pertinent agencies as maybe needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan;**

WHEREAS, the SK *Barangay Putatan* FY 2025 Annual Budget was found to have substantially complied with the laws and the same was executed pursuant to the prescribed power of the barangay;

NOW THEREFORE, BE IT ENACTED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to approved the **2025 Annual Budget of Sangguniang Kabataan (SK) Budget of Barangay Putatan**, amounting to **Fifteen Million Five Hundred Forty-Nine Thousand Two Hundred Sixteen Pesos And 01/100 (Php15,549,216.01).**

ENACTED, by the 10<sup>th</sup> **Sangguniang Panlungsod of Muntinlupa** this 24<sup>th</sup> day of **February 2025**, on its 135<sup>th</sup> **Regular Session.**
