WHEREAS, Section 16 of Republic Act 7160 or the Local Government Code of 1991, provides that, "Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare":

WHEREAS, Section 22(c), Supra, further provide that, "unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned

WHEREAS, the Colegio de Muntinlupa (CDM) was established through Ordinance 17-076 with the following objective: "to primarily provide higher and globally competitive technological, professional and vocational instruction and training in, such as but not limited to, architecture, engineering, sciences, fisheries, trades and technology, as well as short term technical or vocational courses, as the Board of Trustees may deem necessary to meet the demands of an emerging industrial society and shall promote researches in the exploitation and conservation of the natural resources, and other scientific and technological fields, as well as maintenance of ecological balance in the City."

Such venture is attainable through collaborations and partnerships with national and international entities specializing in technological, professional and vocational instruction;

WHEREAS, CDM has established linkages and connection with various industry partners with specialization in microelectronics and integrated circuit design. These industry partners are willing to share its expertise and resources in curriculum development, internship and on-the-job training, research and development projects, workshops and seminars and possible scholarship grants;

WHEREAS, collaboration with industry partners on microelectronics and integrated circuit design, though unnamed in a memorandum of understanding to be signed by the City Mayor, is allowed as long as parties complied with pertinent CHED and DOLE guidelines and issuances, the vetting of the controlling industry parties and to submission of the required authority of the representative/s of the party/ies.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa, to adopt a resolution authorizing the City Mayor Hon. Rozzano Rufino B. Biazon to sign and execute Memoranda of Agreements (MOAS) with Industry Partner/S of Colegio De Muntinlupa for Multiple Collaborations in the Field of Microelectronics and Integrated Circuit Design such as Curriculum Development, Internship and On-The-Job Training, Researce and Development Projects, Workshops and Seminars and possible Scholarship Grants
