
WHEREAS, Section 16 of Republic Act 7160 or the Local Government Code of 1991, provides that, "Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare":

WHEREAS, Section 22(c), Supra, further provide that, "unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned

WHEREAS, the Colegio de Muntinlupa (CDM) was established through Ordinance 17-076 with the following objective: "to primarily provide higher and globally competitive technological, professional and vocational instruction and training in, such as but not limited to, architecture, engineering, sciences, fisheries, trades and technology, as well as short term technical or vocational courses, as the Board of Trustees may deem necessary to meet the demands of an emerging industrial society and shall promote researches in the exploitation and conservation of the natural resources, and other scientific and technological fields, as well as maintenance of ecological balance in the City."

WHEREAS, to attain the aforecited objectives, it is imperative that the graduates/students of CDM not only be equipped with knowledge but also the trainings to hurdle state managed examinations;

WHEREAS, the City Mayor to give him authority to enter into and sign the Memorandum of Understanding (MOU) with Lunghwa of Science and Technology and CDM on the implementation of a partnership done through various programs and initiative;

WHEREAS, the revised Memorandum of Understanding (MOU), the Colegion De Muntinlupa (CDM) and Lunghwa of Science and Technology (Taiwan) will establishes a collaboration between the parties the conduct of activities or program such as:

a. Exchange of students and/or faculty members,

- b. Bachelor degrees programs, including internship,
- c. Joint cultural or research programs,

d. Exchange of information, etc..

WHEREAS, The MOU shall be effective upon execution by the parties and shall remain effect for two (2) years only and renewable.

WHEREAS, the City Legal Office has posses no objection thereto, subject to compliance with pertinent CHED guidelines and International linkage and pertinent issuances, with reservation of our right to review separate MOU for each activity/program before signing the MOU;

NOW THEREFORE, BE IT RESOLVED, TAS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the *City Mayor Hon. Rozzano Rufino B. Biazon* to enter into and sign the Memorandum of Agreement (MOA) to represent the Colegio de Muntinlupa (CDM) with *Lunghwa of Science and Technology (TAIWAN)*, on the implementation of a partnership done through various programs and initiative.
