WHEREAS, Section 16 of Republic Act No. 7160 Local Government Code of 1991, mandates all local government units to ensure and maintain peace and order within their respective areas, among other concerns;

WHEREAS, pursuant to Executive Order No. 773, series of 2009, as amended, the Muntinlupa City Peace and Order Council (CPOC) shall plan and implement measures which will further improve the peace and order and public safety within their area of responsibility, and to monitor peace and order and public safety (POPS) situation;

WHEREAS, Memorandum Circular No. 2022-118 issued by the Department of Interior and Local Government provides for the guidelines on the development and formulation of the Peace and Order and Public Safety Plan (POPS-PLAN) 2023-2025;

WHEREAS, on January 2023, the Sanggunian adopted 2023-172 relative to the POPS Plan for 2023-2025. The same plan was revised through Sanggunian Resolution No. 2023-376, citing the need to revise the same to be more responsive to the urgent and present need of the constituents;

WHEREAS, on 22nd October 2024, the Peace and Order Council issued its Resolution No. 2024-007 adopting the POPS PLAN for Fiscal Year 2025 and the Revised POPS PLAN FY 2023-2025;
