WHEREAS, Section 20, Article II of the 1987 Constitution on the Declaration of State Policies, states that "The State recognizes the indispensable role of the private sector, xxx;"

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that "Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 455 (b)(1)(vi) of the LGC states that "The City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance;"

WHEREAS, Article 47(a), Rule IX of the Implementing Rules and Regulations of the LGC on the Corporate Powers and Corporate Seal of the Local Government Unit, provides that "Unless otherwise provided in the Code, no contract may be entered into by the Local Chief Executive in behalf of the LGU without prior authorization by the Sanggunian;"

WHEREAS, Article II, Section 4(d) and (e) of R.A. No. 7926, also known as the **Charter of the City of Muntinlupa (Charter)**, empowers the City, as a political body corporate, "to acquire and convey real or personal property, and to enter into contracts;"

WHEREAS, Land Bank of the Philippines (LBP) is a government financial institution and an authorized government depository bank (AGDB) with which the City Government of Muntinlupa (CGM) maintains several accounts;

WHEREAS, the City Government of Muntinlupa, in addition to the accounts being maintained with the LBP, desires to avail of the latter's ATM Payroll facility for the **Pamantsan ng Muntinlupa (PLMun)** personnel;

WHEREAS, the MOA contemplates the crediting of salaries, allowances, bonuses, other collateral allowances, including benefits from CGM's personnel through the **LBP-ATM Payroll Facility** using the Land Bank Visa Electronic Card;

WHEREAS, the City Legal Office, has no objection to the Memorandum of Agreement (MOA) finding the provisions/terms and conditions thereof to be sound and reasonable and not contrary to law, public policy, public order, customs and morals.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize **Hon. Mayor Rozzano Rufino B. Biazon**, on behalf of the City Government of Muntinlupa, to enter into and sign the Memorandum of Agreement (MOA) with the **Landbank of the Philippines (LBP)** on the implementation of the ATM payroll to all personnel of the **Pamantasan ng Lungsod ng Muntinlupa (PIMun)** using the Land Bank Visa Electronic Card.

ADOPTED, by the 10th **Sangguniang Panlungsod of Muntinlupa** this 27th day of **January, 2025** on its 131st **Regular Session**.
