WHEREAS, Republic Act 7160 or the Local Government Code of 1991 provides that, "National agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects."

WHEREAS, Section 455 (b)(1)g(vi) of the Local Government Code provides that, the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants Pursuant to Sec 76 of RA7160, the city mayor shall represent the city in all business obligations, transactions and sign in its behalf all bonds, contracts and such other documents upon authority of the Sangguniang Panlungsod;

WHEREAS, the DSWD issued Memorandum Circular No 10, series of 2018 providing for the Guidelines on the provision of the Technical Assistance And Resource Augmentation (TARA) to Local Government Units through the Local Social Welfare and Development Office (LSWDO);

WHEREAS, the TARA Program covers LSWDOs (including the offices of LGUs for senior citizens, persons with disability and other vulnerable and marginalized sectors whether or not directly under the supervision of the LSWDOs) to operationalize the delivery of social welfare and development programs by the LGUs and
