WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, "Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC (LGC-IRR), provides that, "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, RA 7160 likewise provides for the inter-local government units cooperation on grants, subsidies and other matters which are mutually beneficial for them;

WHEREAS, Republic Act 7719 otherwise known as the National Blood Services Act of 1994 promotes voluntary blood donation in public education, promotion in schools, professional education, establishments of blood services networks and walking blood donors;

WHEREAS, same Act provides for the regulation of Blood Services where It shall be unlawful for any person to establish and operate a blood bank/center unless it is registered and issued a license to operate by the Department of Health;

WHEREAS, the Las Piñas General Hospital and Satellite Trauma Center (LPGH-STC) as the lead blood Service facility, collaborates with the Ospital ng Muntinlupa, acting as a Satellite Facility, for blood services which includes the recruiting and care for voluntary blood donors and issuance of blood and blood components;

**WHEREAS**, the MOA was reviewed by the City Legal Office which interposed no objection to the terms and conditions contained therein.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, authorizing the City Mayor Rozzano Rufino B. Biazon to enter into a Memorandum of Agreement with Las Piñas General Hospital and Satellite Trauma Center (LPGH-STC) for the implementation of a blood service program with the OSPITAL NG MUNTINLUPA pursuant to National Voluntary Blood Service Program of the Department of Health (DOH)

ADOPTED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 3rd day of February 2025, on its 132nd Regular Session.
