WHEREAS, Section 25 of the LGC authorizes, "National agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects;"

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "**(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.**";

WHEREAS, according to the World Health organization life skills are a group of psychosocial competencies and interpersonal skills that help people make informed decisions, solve problems, think critically and creatively, communicate effectively, build healthy relationships, empathize with others, and cope with and manage their lives in a healthy and productive manner;

Decision Making	Capacity to evaluate and to execute appropriate action plans in a particular situation (personal and work life)
Planning and Organizing	Capacity to develop short and long-term goals in the work place
Self motivation	Capacity to motivate oneself and to develop SMART goals
Math functional skills	Capacity to basic mathematical operations using critical thinking
Social perceptiveness	Capacity to apply interpersonal competencies in dealing with issues, concerns, and challenges in the workplace
Problem sensitivity	One's sensitivity in terms of workplace, challenges, issues and concerns
Multi-tasking	Capacity to delegate, supervise and manage several tasks at a given time
Stress tolerance	Capacity to tolerate and to manage one's stressors at work and personal life
Critical thinking	Applying skills in logical and analytical thinking patterns in real-life
Creative problem-solving	Applying logical and outside-the-box thinking pattern in real-life setting
Teamwork	Capacity to work harmoniously with others
Innovation	Capacity to generate outside-the-box ideas and applying them in the most practical issue
Work standards/Ethics	Capacity to apply and to abide with ethical standards, work habits and protocols in the workplace
English Comprehension	Capacity to comprehend and synthesize information using the English language, critical and creative thinking
English functional skills	Capacity to execute basic English grammar rules in both oral and written communication
Digital Literacy	Capacity to use technology effectively, responsively and critically
Data Privacy Act	Capacity to use information/data appropriately and fairly
