THIS AGREEMENT made the ____ day of ____ 20___ between **CITY GOVERNMENT OF MUNTINLUPA** of the Philippines (hereinafter called "the Entity") of the one part and **KLEAL ENTERTAINMENT PRODUCTION** with address at Rodriguez, Rizal (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **Rental of Full Technical Equipment & Production Management for R-18 Month Celebration** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Eight Hundred Ninety Nine Thousand Pesos (P1,899,000.00)** (hereinafter called "the Contract Price").

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
