AN ORDINANCE ON THE UPGRADING OF PSYCHOLOGIST
POSITIONS IN THE CITY GOVERNMENT OF MUNTINLUPA
AND PROVIDING FUNDS THEREFOR

WHEREAS, on December 10, 2024 the Department of Budget and Management (DBM) issued Budget Circular No. 2024-5 Upgrading of the Psychologist Position, existing or to be created in the national government agencies, including the local government units covered by the Compensation and Position Classification Act of 1998, as amended;

WHEREAS, the same DBM Circular provides that the upgraded positions shall be effective not earlier than January 1, 2025;

WHEREAS, the City Government of Muntinlupa has Psychologists positions at the offices of the Drug Abuse Prevention and Control Office (DAPCO), Public Employment Service Office (PESO):

WHEREAS, the DBM Circular Circular No. 2024-5 also provides, "The amounts required to implement the salary upgrading shall be charged exclusively to the funds of the LGUs, subject to the PS limitation in LGU budgets pursuant to Section 325 (a) and 331 (b) of RA 7160.";

WHEREAS, the City Budget Office certified that there is a budgetary savings in the first quarter of FY 2025 Personal Services which may be utilized to fund the salary adjustment required by the circular;

NOW THEREFORE, BE IT ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa, in Session assembled that:

SECTION 1. Upgrading of Psychologists position. The position of Psychologist, existing and to be created, in the offices of the City Government of Muntinlupa shall be upgraded to conform with the following adjustments:

Position Title	Salary Grade	
	From	To
Psychologist I	11	16
Psychologist II	15	18
Psychologist III	18	20

SECTION 2. Funding Source. The fund for the implementation of this ordinance shall, for the current year, be sourced from the 2025 budgetary savings of the Personal Services;

SECTION 3. Adjustments and Allocation. The City Human Resource Management Department is tasked to adjust the salary grades of the occupied and vacant position title and coordinate with the City Budget Office for the annual allocation of the amount needed for the implementation of this ordinance;

SECTION 4. Repealing Clause. Policies or any existing rules, ordinances and other issuances or portions thereof inconsistent with the provisions of this Ordinance are hereby revoked or repealed accordingly.

SECTION 5. Separability Clause. If any provision of this Ordinance is held invalid or unconstitutional, other provisions unaffected thereby shall continue to be in full force and effect,

SECTION 6. Effectivity. This Ordinance shall take effect upon its approval.

ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 17th day of March 2025, on its 138th Regular Session.


