AN ORDINANCE APPROPRIATING THE AMOUNT OF THIRTY THOUSAND PESOS (PHP30,000.00) FINANCIAL ASSISTANCE FOR THE VICTIM OF FIRE WHICH OCCURED AT NO. 463 PUROK 3, BARANGAY CUPANG, MUNTINLUPA CITY ON MARCH 16, 2025

WHEREAS, Section 16 of the Local Government Code (LGC) of 1991 states that *"Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare"*:

WHEREAS, Section 458 (a)(1)(iv) of the LGC 1991 empowers the Sanggunian, *"to adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx"*;

WHEREAS, Section 4 of Ordinance No. 2024-240 otherwise known as, **An Ordinance on the Increase of Financial Assistance for the Victims of Fire In Muntinlupa City**, provides for financial assistance to victims of fire based on the category of residence and scope of damage to the property;

WHEREAS, on March 16, 2025 a fire broke out at **No. 463 Pirok 3, Barangay Cupang, Muntinlupa Cit;**

WHEREAS, the report rendered by the Social Services Department after the mapping operations of the area, concluded that there was family whose structure was affected by the blaze that need immediate assistance;

NOW THEREFORE, BE IT ENACTED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, in Session assembled that:

**SECTION 1. Appropriation.** There is hereby appropriated the amount of **Thirty Thousand Pesos (PHP30,000.00)** financial assistance for the victim of fire distributed as follow:

**SECTION 2. Source of Fund.** The amount herein allocated shall be sourced from the Quick Response Fund of the Department of Disaster Resilience and Management;

**SECTION 3. Accountability.** The Social Services Department shall prepare and distribute the financial assistance herein indicated taking into consideration the prevailing accounting and auditing guidelines.

**SECTION 4. Effectivity.** This Ordinance shall take effect upon its approval.
