**WHEREAS**, Section 57 of the Local Government Code of 1991 provides, "(a) Within ten (10) days after its enactment, the Sangguniang Barangay shall furnish copies of all Barangay ordinances to the Sangguniang Panlungsod or Sangguniang bayan concerned for review as to whether the ordinance is consistent with law and city or municipal ordinances.";

**WHEREAS**, on December 4, 2024 the Sangguniang Barangay of Alabang enacted Barangay Ordinance No. 24-005 or an Ordinance Implementing the Halina't Magtanim ng Prutas at Gulay (HAPAG) sa Barangay Program in Barangay Alabang, Muntinlupa City;

**WHEREAS**, the Department of Interior and Local Government (DILG) issued Memorandum Circular 2023-001 on the implementation of the Halina't Magtanim ng Prutas at Gulay pursuant to the pronouncements of the President of the Philippines, the Local Government Code and Ambisyon 2040;

**WHEREAS**, the City Government likewise support the program on urban gardening as a means to curb or lessen hunger and malnutrition in the City, thereby the HAPAG is initiated and implemented by the City;

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa to affirm **Ordinance No. 24-005 or an Ordinance Implementing The Halina't Magtanim Ng Prutas At Gulay**

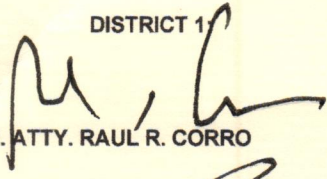


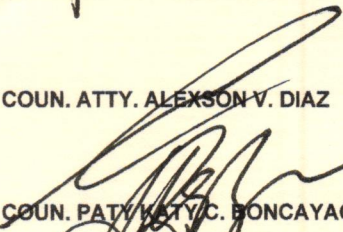
