THIS AGREEMENT made the day of 1.9 2025 between CITY GOVERNMENT  OF MUNTINLUPA of the Philippines (hereinafter called "the Entity") of the one part and CHARKIEL  ENTERPRISES with address at Muntinlupa City (hereinafter called "the Supplier") of the other part;
WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the Supply & Delivery of Grocery Items for the Implementation of Projects Reach: Seniors Serving Seniors and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Three Hundred Fifteen Thousand Two Hundred Thirty Pesos & 30/100 (P1,315,230.30) (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
