

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the Supply & Delivery of Various Furniture & Fixtures to be used by C.H.O. and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million One Hundred Twenty Six Thousand Six Hundred Ninety Six Pesos (P1,126,696.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
